From the President

Dear Alumni,

Over the years we have made financial requests in the Shoreline. This year I find it necessary to make another plea for help. As I write this, the Village is enjoying a mild November with the beautiful Fall foliage almost gone – the Service Department is going the extra mile to pick up the piles of leaves throughout the Village.

The Election has resulted in the re-election of Mayor Debbie Sutherland (Class of '72) in a very close race. Debbie won with 3,409 votes or 50.6% of the vote, while Jim Scott (Councilman-at-Large) received 3,331 votes or 49.4% of the total vote. Dwight Clark (un-opposed) won Councilman-at-Large. Paul Koomar, Ward 2, won against challenger, Jeanette McGovern. Wards 1, 3, and 4 were re-elected without opposition. The School Board election added two new members, Michael Caputo and Gayatry Jacob-Mosier, with Amy Huntley being re-elected with the majority of the votes. Cuyahoga County voters voted to change the structure of County Government from three Commissioners to a Chief Executive with eleven Councilmen.

Thanks to the many contributors to the celebration of the Village's Bicentennial – **Please continue!** The celebration events are extensive and will start with a monthly event culminating in the final celebration on October 10th of 2010.

The Shoreline newsletter needs your support. Your contributions keep the presses rolling and help us provide the news and remembrances that you look forward to with every issue.

The Alumni Foundation is increasing with new members attending our meetings on the first Monday of each month. If you live in the area, please feel free to come to our meetings. The meetings start at 7:00 PM in the community room of the new Police Station. These meetings are brief and are attended by class members of all ages.

Holidays are close, and that will bring many of you back to the Village where you grew up – if not in person – perhaps in thought. It is still the wonderful community that you remember with many positive changes.

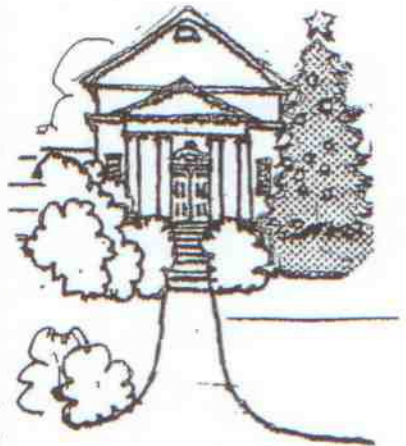
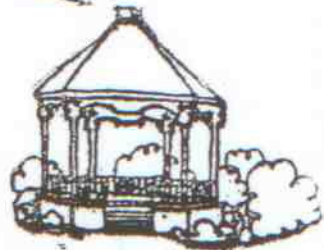

The surgeon indicated that as a result, the possibility of actually puncturing the lung when the surgeon cut into the breastbone was likely. Because Dale’s current condition is not life threatening and because there is a good possibility that in two to three years there will be a non-invasive way to replace the heart valve (currently in FDA trials), we decided to cancel the surgery.
